They died without their families knowing if they will get the much-needed financial lifeline of a full VCF award. The amendments offered by Senators Lee and Paul will only delay this vital legislation and create more uncertainty for 9/11 responders and their families.

Senator Lee's amendment would cap the program at \$10.2 billion for the first ten years and then cap funding at \$10 billion for the remainder of the life of the program. We have done this dance before in 2010 and 2015 and each time the funding was not enough. 9/11 responders had to come back to Congress and ask for more funding. The 2015 bill ran out of funding in three years, which is why we are back fighting to permanently reauthorize this program, why NYPD Detective Luis Alvarez came back to testify before the House Judiciary Committee just weeks before he succumbed to a 9/11-related cancer. We cannot ask these heroes, who responded to the World Trade Center, the Pentagon and Shanksville on September 11, 2001, and put in thousands of hours doing rescue and recovery work, to come back yet again to ask for more money. This amendment defeats the purpose of this bill.

Senator Paul's amendment would implement a \$2 billion across-the-board cut to all federal spending over five years.
