Each year, the approach of September 11th brings fresh reminders of the nearly 3,000 men, women, and children who perished in the air and on the ground on that fateful day in 2001. It also reminds us that the toll of the 9/11 attacks is still being felt in communities across this country. This includes nearly 250 members of the NYPD who have died from a World Trade Center (WTC)-related health condition and 115,000 Americans who are receiving health monitoring or treatment through the World Trade Center Health Program (WTCHP). To date, more than 68,000 individuals have been certified with at least one WTC-related health condition, including various types of cancer, aerodigestive disease, and WTC-exacerbated Chronic Obstructive Pulmonary Disease. Today the WTCHP serves individuals in all 50 U.S. states and in 434 of the nation's 435 congressional districts.

Since its creation in 2011, those who are sick and those exposed to the deadly cocktail of toxins at Ground Zero have found support and assistance through the WTCHP. The passage in 2015 of the James Zadroga 9/11 Health and Compensation Act permanently reauthorized this vital program, ensuring that those who suffered long-term health effects from the countless hours spent engaging in rescue and recovery efforts would not be forgotten. In the coming years, however, the funding needs of the program will exceed the formula written into that law. If left unaddressed, the WTCHP will not have the resources necessary to continue providing care for those still suffering from the aftermath of the 9/11 attacks.

The legislation you have introduced ensures the continuation of the vital health services provided by the WTCHP and supports the important ongoing research into the diagnosis and treatment of WTC-related health conditions. Specifically, H.R. 4965 will revise the existing statutory funding formula to enable the WTCHP to continue its important work on behalf of 9/11 responders. The bill also makes important changes to improve the ability of the WTCHP to certify both health care providers and WTC-related health conditions, as well as provide an increase of \$5 million per year for research activities.

The SBA is proud to stand beside you again as we fight to ensure the continuation of the WTCHP's important work on behalf of our nation's 9/11 responders.
